
- Innocent Until Proven Guilty

- 2= Failure, Injuries can affect
- Each Clue

- 13 Instructions, 1x Given, 1x Demo, 0 Practice, 0 Clues Told
- 2= Failure, Injuries can affect
- Each Clue




### 7. Breath Test - 15 Min. Violation

• 15 Minutes — Line of Sight

● DPS – 21 Minute Video

## 8. Breath Test - Walking It Down

- 0.02 Breath Samples
- 0.01 Reference Sample Solution
- 0.009 Truncation
- 34 +/- 0.2° Celsius



- 8.62% high for every one degree Celsius
  - $98.6^{\circ} \text{ F} = 37^{\circ} \text{ C}$

## 9. Blood - McNeely & Bullcoming

- Missouri v. McNeely
  - Totality of the Circumstances
  - Exigency Not metabolization or dissipation
  - Clay v. State, 382 S.W.3d 465 (Tex.App.—Waco 2012), review granted, (June 27, 2012).
- Bullcoming v. New Mexico
  - Analyst that tested
    - Preparation of Sample
    - Mixing Vials



### 10. Disconnect Defense

- High Blood Test (0.15 and higher)
- Good Video Performance
- Indisputable Conflict
  - Alleged blood alcohol science
  - Common sense theme of believing what you see.
  - e.g. a DISCONNECT

### **DISCONNECT In A Nutshell**

- Systematically weaved reasonable doubt through every aspect of intoxication
- Indisputable Conflict = Reasonable Doubt
  - Innocent Man, Insufficient Evidence, Indisputable Conflict
- Use Demonstrations
  - Green, Green, Red
  - Hypothetical Machine
  - Pictures with ridiculous stats
- DISCONNECT: good video, no loss of mental or physical faculties, never urinated, all about the ridiculously high number, either the machine defies science or there is a problem
- Constitutional Duty to Find Defendant NOT GUILTY

### Breath v. Blood

- (1) 20% acceptable range of error;
- (2) self checking for accuracy;
- (3) no warranty for merchantability or accuracy;
- (4) recalled in multiple states;
- (5) newer model available;
- (6) citizen cannot purchase from manufacturer;
- (7) manufacturer refuses to provide source code;
- (8) not available for independent scientific testing;
- (9) destroys the only direct evidence of sobriety/intoxication when the State had the ability to save that evidence;
- (10) operator has no idea how the machine works;
- (11) "scientist," who does, rarely checks it in person;
- (12) any inconsistencies or strange occurrences found in test records; etc...


- (1) contamination in the blood draw room;
- (2) expired materials;
- (3) improper site cleansing;
- (4) improper blood draw technique;
- (5) mishandling of the evidence;
- (6) break in the chain of custody;
- (7) human error in the laboratory;
- (8) pipette problems;
- (9) sample expiration, contamination, or other problems;
- (10) contamination in the injector port, y-splitter, columns, flam ionization detector;
- (11) source code issue;
- (12) sloppy chromatography,
- (13) 0.000
