Machines

- <u>Happy Everyday Airlines hypothetical</u>
 - > Best prices, clean, I free checked bag UNDER 50lbs
 - > If you lie and bag over 50lbs \$2k and 180 days in jail
 - > Bubba big guy (300 lbs), lifts bags all day, FAA license
 - > How do you measure? GC scale too long & expensive
 - HEA scale Bubba measures his weight, then grabs bag, and subtracts weight
 - SNOW unusual, snow boots, hat, gloves, big coat, big breakfast, chili lunch, lots of water
 - > How does that make you feel?

Machines (part 2)

- Problems:
 - > Did he tare the scale?
 - > Subtract clothes, food, drink in order to be reliable
- Problem with Scales: naked or rocks in pockets
- Can't differentiate where weight comes from!
- 200lb bag 4x the limit, know how it looks
- Common Sense vs. Ridiculous Number

Presumption of Innocence

Only I Presumption – Innocent

- NOT intoxicated, officer judgment correct, officer administered tests properly, machine is working properly, Bubba didn't forget any subtractions
- Ompass Takes you home Not Guilty

Burdens of Proof

- P.C. to arrest or write a ticket
- Preponderance 51%, civil, 1 million dollars
- Clear and Convincing CPS, child fell on swings
 BEYOND
- <u>A</u>
 REASONABLE
 DOUBT

- Always refer to each juror by name, not number.
- Show personality and emotions.
- Share something endearing about yourself.
- Citizen's lawyer, not there in defiance of DWI laws.
- Orinking patterns

- Ask open ended questions and loop down the row.
- Capitalize on great answers.
- Acknowledge and deal with your difficult facts.
- BT- Thermometer/ Taxalyzer 5000EN
- BEYOND A REASONABLE DOUBT.
- Presumption of Innocence.
- 5th Amendment.
- Rehabilitate.
- Know how to preserve the record.
